ADAMS COUNTY, COLORADO SERVICE AGREEMENT ADDENDUM TWO

THIS ADDENDUM TWO ("Addendum Two") is made this 3 day of 1000 2016, by and between the Adams County Board of County Commissioners, located at 4430 South Adams County Parkway, Brighton, Colorado 80601, hereinafter referred to as the "County," and MAPLE STAR COLORADO, located at 2250 South Oneida Street, Denver, CO 80224, hereinafter referred to as the "Contractor." The County and the Contractor may be collectively referred to herein as the "Parties".

RECITALS

WHEREAS, on July 21, 2015, the County entered into Addendum One #2015.450 with Maple Star Colorado to provide Diligent Search Services for the Adams Human Services Children and Family Center, and.

WHEREAS, the County and the Contractor mutually desire to amend the Service Agreement to extend for one additional year effective June 30, 2016 pursuant to Section 3 TERM, Paragraph 3.2 Extension Options.

NOW, THEREFORE, for the consideration set forth herein, the sufficiency of which is mutually acknowledged by the parties, the County and the Contractor agree as follows:

- 1. The County shall pay the Contractor for the services furnished under this Addendum Two in accordance with Section IV Payment and Fee Schedule for a sum not to exceed one-hundred twenty thousand dollars and no cents (\$120,000.00) for last option year.
- 2. The term of the Service Agreement is extended for one (1) additional year effective through June 30, 2017.
- 3. The Service Agreement, Addendum One and Addendum Two contain the entire understanding of the parties hereto and neither it, nor the rights and obligations hereunder, may be changed, modified, or waived except by an instrument in writing that is signed by both parties. Any terms, conditions, or provisions of the Service Agreement that are not amended or modified by Addendum Two shall remain in full force and effect. In the event of any conflicts between the terms, conditions, or provisions of the Service Agreement, Addendum One, and Addendum Two the terms, conditions, and provisions of Addendum Two shall prevail.
- 4. The Recitals contained in Addendum Two are incorporated into the body hereof, and accurately reflect the intent and agreement of the parties.
- 5. Addendum Two may be executed in multiple counterparts, each of which shall be deemed to be an original and all of which taken together shall constitute one and the same agreement.
- 6. Nothing expressed or implied in Addendum Two is intended or shall be construed to confer upon or to give to, any person other than the parties, any right, remedy, or claim under or by reason of Addendum Two or any terms, conditions, or provisions hereof. All terms, conditions, and provisions in Addendum Two by and on behalf of the County and the Contractor shall be for the sole and exclusive benefit of the County and the Contractor.

- 7. If any provision of Addendum Two is determined to be unenforceable or invalid for any reason, the remainder of Addendum Two shall remain in effect, unless otherwise terminated in accordance with the terms contained in the Service Agreement.
- 8. Each party represents and warrants that it has the power and ability to enter into Addendum Two, to grant the rights granted herein, and to perform the duties and obligations herein described.
