SERVICE AGREEMENT
AMENDMENT TWO

THIS AMENDMENT TO THE SERVICE AGREEMENT ("Amendment") is entered into this _____ day of _____, 2016, by and between the Board of County Commissioners of Adams County, Colorado, located at 4430 South Adams County Parkway, Brighton, CO 80601, hereinafter referred to as the "County," and **Armored Knights Inc.**, located at 375 Yuma Street, Denver, Colorado 80204 hereinafter referred to as the "Contractor." The County and the Contractor may be collectively referred to herein as the "Parties".

RECITALS

WHEREAS, on March 20, 2015, the County entered into Service Agreement 2015.416 with **Armored Knights Inc.** to provide Armored Car Services; and,

WHEREAS, on February 11, 2016 the County and the Contractor amended the Agreement revising the location schedule and additional services; and,

WHEREAS, the County and the Contractor mutually desire to update Exhibit A of the Agreement with a revised location schedule and extend the Agreement for one year, beginning January 1, 2016 through December 31, 2016.

NOW, THEREFORE, for the consideration set forth herein, the sufficiency of which is mutually acknowledged by the Parties, the County and the Contractor agree as follows:

1. Exhibit A shall be revised to reflect updated location schedules attached hereto as Exhibit A.
2. The term of the Agreement is extended for one year beginning January 1, 2016 through December 31, 2016.
3. The County shall reimburse the Contractor for the work provided under Amendment Two in accordance with Section IV of the Service Agreement. Adams County will pay the Contractor forty-one thousand nine hundred and thirty seven dollars and forty-six cents (\$41,937.46).
4. The Service Agreement and Amendment Two contain the entire understanding of the parties hereto and neither it, nor the rights and obligations hereunder, may be changed, modified, or waived except by an instrument in writing that is signed by both parties. Any terms, conditions, or provisions of the Service Agreement that are not amended or modified by Amendment Two shall remain in full force and effect. In the event of any conflicts between the terms, conditions, or provisions of the Service Agreement the terms, conditions, and provisions of Amendment Two shall prevail.
5. The Recitals contained in Amendment Two are incorporated into the body hereof, and accurately reflect the intent and agreement of the parties.

- 6. Amendment Two may be executed in multiple counterparts, each of which shall be deemed to be an original and all of which taken together shall constitute one and the same agreement.
- 7. Nothing expressed or implied in Amendment Two is intended or shall be construed to confer upon or to give to, any person other than the parties, any right, remedy, or claim under or by reason of Amendment Two or any terms, conditions, or provisions hereof. All terms, conditions, and provisions in Amendment Two by and on behalf of the County and the Contractor shall be for the sole and exclusive benefit of the County and the Contractor.
- 8. If any provision of Amendment Two is determined to be unenforceable or invalid for any reason, the remainder of Amendment Two shall remain in effect, unless otherwise terminated in accordance with the terms contained in the Service Agreement.
- 9. Each party represents and warrants that it has the power and ability to enter into Amendment Two, to grant the rights granted herein, and to perform the duties and obligations herein described.
