## ADAMS COUNTY, COLORADO THIRD ADDENDUM TO SERVICE AGREEMENT

THIS THIRD ADDENDUM TO SERVICE AGREEMENT ("Third Addendum") is entered into this 25 day of OCTODOC, 2016, by and between the Board of County Commissioners of Adams County, Colorado, located at 4430 South Adams County Parkway, Brighton, CO 80601, hereinafter referred to as the "County," and Maple Star Colorado, 2250 South Oneida Street, Suite 100, Denver, Colorado, 80224, hereinafter referred to as the "Contractor."

## **RECITALS**

WHEREAS, on February 27, 2013, the County entered into a Service Agreement with Maple Star Colorado to provide Domestic Violence Reduction Services for the Adams County Department of Human Services/Division of Children and Family Services; and,

WHEREAS, the County extended the agreement for one (1) additional eighteen (18) month term beginning January 1, 2014 through June 30, 2015; and,

WHEREAS, Maple Star Colorado agrees to hold pricing throughout the 2015/2016 renewal; and,

WHEREAS, the County and the Contractor mutually agreed to amend the Service Agreement to extend the term beginning July 1, 2015 through June 30, 2016; and,

WHEREAS, the County and the Contractor mutually desire to amend the Service Agreement to extend the term beginning July 1, 2016 through September 30, 2016.

NOW, THEREFORE, for the consideration set forth herein, the sufficiency of which is mutually acknowledged by the parties, the County and the Contractor agree as follows:

- 1. The Service Agreement is hereby amended to extend the term of the Agreement from July 1, 2016 through September 30, 2016.
- 2. The fee schedule will remain as follows:

Nothing expressed or implied in this Third Addendum is intended or shall be construed to confer upon or to give to, any person other than the parties, any right, remedy, or claim under or by reason of this Third Addendum or any terms, conditions, or provisions hereof. All terms, conditions, and provisions in this Third Addendum by and on behalf of the County and the Contractor shall be for the sole and exclusive benefit of the County and the Contractor.

- 4. If any provision of this Third Addendum is determined to be unenforceable or invalid for any reason, the remainder of the Third Addendum shall remain in effect, unless otherwise terminated in accordance with the terms contained in the Service Agreement.
- Each party represents and warrants that it has the power and ability to enter into this
  Third Addendum, to grant the rights granted herein, and to perform the duties and
  obligations herein described.
