HOMELESSNESS PREVENTION

INCREASING EVICTION FILINGS

In 2022, Denver County received 8,879 eviction filings. That is more than 2020 and 2021 combined. We are seeing the same trend in Adams County with 2,922 filings in 2022 alone. Evictions lead to generational instability often starting with homelessness. This winter, we have seen evictions increasing the demand for cold weather hotel youchers.

AMERICAN RESCUE PLAN FUNDING DECISIONS

On Tuesday, Feb. 7, the Adams County
Board of Commissioners approved the
American Rescue Plan Act (ARPA)
Tranche 2 allocation. Adams County
allocated funding for the Homelessness
Campus partnership with City of Aurora,
Mobile Mental Health, Domestic Violence
Respite Housing, Rapid Rehousing, and
Tiny Home Villages.

MARCH NAVIGATE ADAMS **RESOURCE FAIR**

On March 23, we are hosting a resource fair at the Impacto De Fe Church in Commerce City. Individuals struggling with housing insecurity and homelessness are encouraged to attend. There will be representatives from the community available to provide information on shelter, housing, pet care, employment, and more.

THE 2023 POINT-IN-TIME (PIT) COUNT **COMPLETED**

On Jan. 31, over 100 volunteers surveyed people experiencing homelessness across Adams County. The PIT Count provides a snapshot of the number of people experiencing homelessness on a single day. The Department of Housing & Urban Development uses PIT Count data to make funding decisions. Thank you to all of the volunteers who participated.



SEVERE WEATHER ACTIVATION PROGRAM CONTINUOUSLY EXPANDS

The Severe Weather Activation Program (SWAP) provides hotel vouchers to unsheltered individuals during extreme weather. From November 2022, to February 2023, there were 2,246 vouchers distributed, resulting in 12,246 nights of unsheltered homelessness averted, the highest number to date. Thank you to all voucher distributers for continuing to save lives.



ELEVATING VOICES SERIES: ARTIST INTRODUCTION

Local artist Shaunie Berry will host free artmaking sessions this spring for people experiencing homelessness. The sessions will explore multiple artforms to foster space for connection. Her engagement with residents will complement the existing provision of services. Shaunie will commemorate the project with an original art piece inspired by her experience. LIVED EXPERIENCE COMMITTEE

The first committee meeting for Adams and Jefferson County residents with lived experience of homelessness will be held on March 15, from 5:30 - 7:30 p.m. in Westminster. This will give a voice to those who have experienced homelessness or housing insecurity. Jamie Sherwood, the committee facilitator, believes "their stories can shed light on people still experiencing homelessness and help them out of their situation."



STRENGTHEN THE HOUSING CONTINUUM



March 12 - 18 is #AmeriCorpsWeek 2023! Did you know Department of Community Safety & Well-Being has five AmeriCorpsVISTA members? VISTA members devote a year to community-based, anti-poverty efforts. Ryan Markley is our VISTA Leader, coordinating resource fairs and employment programming. Jamie Sherwood is elevating the voices of people with lived experience of homelessness through committees and events. Jess Swithers is expanding resources for people who are LGBTQ+ and/or disabled including new resource guides. Julia Martinez is hard at work installing community gardens and planting trees in low-income neighborhoods. CREATION OF SUPPORTIVE HOUSING 2022-2023

The Division of Housing is continuing its effort with the Colorado Housing and Finance Authority and local municipalities to increase the production of Permanent Supportive Housing. Applicants can apply for any supportive housing project in Colorado including Project Based Vouchers, Section 8 Vouchers, Tenancy Supportive Services, or Loans or Grants for Affordable Housing. The next Letter of Intent is due on April 23, and the application is due on May 1.
