

**WASHINGTON 25 METROPOLITAN DISTRICT NOS. 1-4
2022 ANNUAL REPORT**

As required by Section 32-1-207(3)(c), C.R.S., and Section VII of the Service Plan for the Washington 25 Metropolitan District Nos. 1-4 (“**Districts**”), approved by the City of Thornton (“**City**”) on August 23, 2016, the Districts hereby submit their annual report for the year ending December 31, 2022:

**RESOLUTION OF THE WASHINGTON 25 METROPOLITAN DISTRICT NO. 1
LEVYING GENERAL PROPERTY TAXES, PURSUANT TO SECTION 39-1-111,


