## Notice of a Proposed Project or Activity Warranting Public Comment

Website Title: Crestone Peak Resources Operating, LLC - Florida 3-65 27-26 - Adams County

Notice is hereby given that an application for a proposed project or activity has been submitted to the Colorado Air Pollution Control Division for the following source of air pollution:

Applicant: Crestone Peak Resources Operating, LLC

Facility: Florida 3-65 27-26  
Well Production Facility  
NWSW Section 27, T3S, R65W  
Adams County

The proposed project or activity is as follows: Crestone Peak Operating, LLC submitted a permit application to modify points 001-003 in construction permit 18AD1338. The modifications include lowering the throughput to the condensate tanks at point 001 and the condensate loadout at point 003, and reducing the throughput and changing the process parameter from liquid throughput to natural gas vented for the VRT at point 002. A Crimson CE1000 enclosed combustion device controls VOC and HAP emissions from all three of these points. The well production facility is located in the severe ozone nonattainment area. The facility is considered a synthetic minor source of VOC under the PSD, NANSR and TV programs. The facility is considered a synthetic minor source of NOx under the NANSR and TV programs.

The Division has determined that this permitting action is subject to public comment per Colorado Regulation No. 3, Part B, Section III.C due to the following reason(s):

- the source is requesting a federally enforceable limit on the potential to emit in order to avoid other requirements

The Division has made a preliminary determination of approval of the application.
