- JEDI- DEI Data Memo- Steve O'Dorisio (update by Karen Schweihs)
  - CJCC Members reviewed data collected and began discussions about how to improve data collections throughout the criminal justice system. Reviewed JEDI Memo. CJCC Members discussed convening data analysts and determined initial contact data collection is important.
- Juvenile Justice- JAC Summit- Terrence Gordon (update by Brian Mason)
  - JAC Summit (8.11.23) convened superintendents, police chiefs & Sheriff, Human Services, city and county leaders to coordinate action steps for building a new juvenile assessment center.
