ACHD was awarded a NACCHO Youth and Community Violence Prevention grant for \$50,000 to fund work from February 2024 through July 2024 to work on youth violence issues in Adams County. Collaborative partners include the Adams County Criminal Justice Coordinating Council (CJCC) Crime Prevention, City of Aurora, the 17<sup>th</sup> Judicial District Attorney's Office, Denver Youth Programs/GRASP, Compound of Compassion, Denver Office of Community Violence Solutions, CSU Extension, CU Anschutz, and multiple Divisions within ACHD. Jamie Rodriguez, ACHD's Regional Health Connector took the lead in writing and submitting the grant and will serve as the convener of the ongoing work group.
