
# Elevate People

### **UP & ADAMS**

Up & Adams is an employment program for people experiencing homelessness that provides paid internship opportunities to acquire job-related training and provide



sustainable and more permanent and meaningful employment. This quarter, we had seven participants enrolled in Up & Adams internships. In late March, Community Safety & Well-Being reviewed submissions from vendors interested in sheltering our Up & Adams participants. We unanimously selected Almost Home to offer 60 days of shelter as well as rental deposit assistance for program participants. This aspect of the program is estimated to launch in May.

# Elevate People

### LIVED EXPERIENCE COMMITTEE

The Lived Experience Committee (LEC) convened in March 2024. The meeting was well attended with 12 residents from Adams and Jefferson counties in attendance. This partnership represents a collaboration between residents who have formerly experienced homelessness, Adams County, and Jefferson County to glean insight regarding homelessness and housing instability. Meeting quarterly, the LEC serves as a vital forum for discussing pressing issues and offering feedback aimed at enhancing community welfare. By leveraging the wisdom and perspectives of those who have triumphed over adversity, the LEC upholds Adams County's vision "to become the most innovative and inclusive county in America for all families and businesses."

## **PATHWAYS TO STABILITY PROGRAM (PSP)**

The Temporary Respite Housing program began in late 2023 to provide bridge housing to households in Adams County taking the final steps to resolve their homelessness. This quarter, we sheltered 12 households, or 24 individuals, providing them a safe space to focus on stability goals with their navigator or case manager. Based on our data, many participants use their time in the hotel to acquire vital records or apply for jobs. We also conducted a comprehensive feedback study that indicated that participants would prefer a different shelter location with more intensive case management. We plan to implement these changes in addition to rebranding the program to "Pathways to Stability."

### AT THE TABLE WITH DOCTOR KING

Juntos CO hosted *At the Table with Dr. King* in collaboration with the Mizel Museum. It was a multifaceted performance that focused on the American Civil Rights movement. It utilized music, poetry, and historical footage from Dr. King's Speech.



#### YOUTH SHELTER OPENED

In early 2024, the Empowerment Center for Adolescents (ECA) opened as Adams County's inaugural youth shelter. The ECA is funded partially by Adams County American Rescue Plan Act funds and serves as a safe interim housing community committed to providing supportive services to displaced youth. This housing community is operated by Community Reach Center and is located in Thornton, Colorado. The program is designed to be a 21-day safe space for adolescents that will provide referrals to comprehensive services to youth who are unaccompanied, runaways, victims of human trafficking, and previously living in uninhabitable housing conditions. The goal is to foster a stable living environment and facilitate access to the necessary services needed for youth to thrive.

# Improve Systems

### **CITATION PROGRAM**

In Q3 of 2023, the BoCC approved a pilot Code Compliance Citation program to be launched in 2024. This program will allow for citations for an approved list of violations of Adams County Standards and Regulations. We have developed policy and procedure for this program and the MOU is fully executed with the sheriff. The job description was developed, approved, and posted and an offer has been made to a candidate. Anticipated hire date is end of May pending background process.



### **UNCONSCIOUS BIAS TRAINING**

In March, Joe Camacho led an unconscious bias training session for the Community Corrections Board and Screening Committee. The goal of the training was to help the board and committee recognize where biases may be within their decision-making process and other aspects of their work in the justice system.

### **TOOLSHED EXPANSION**

Toolshed booking will become available starting April 1st. We are currently exploring options for a barcode inventory system.

# Improve Systems

#### **GRAFFITI EXPANSION**



Meetings have been arranged with a fourth municipality to explore a potential collaboration and Intergovernmental Agreement (IGA) for graffiti removal. Our seasonal employees will also contribute to our regional graffiti clean-up initiatives. CSWB is actively seeking to fill a fourth position through TANF applications to support the above programs, anticipating a surge in demand for the toolshed and block party initiatives, along with the growth of the regional graffiti removal program.

In February, a third Intergovernmental Agreement was finalized. We have initiated clean-up efforts leading to an uptick in graffiti removal activities early in the year. Reflecting our strategy to streamline operations, we've updated our seasonal job description to encompass roles for both the toolshed and block party program with graffiti removal. This adjustment will allow us to optimize recruiting efforts.

Neighborhood and Community Enrichment has developed an outreach strategy to engage schools in utilizing the Block Party Trailer.

Additionally, Neighborhood and Community Enrichment has concentrated efforts on connecting with community leaders with a focus on creating neighborhood groups. This includes promoting programs like the block party trailer

and the toolshed. As of now, we have secured pre-registrations for three events and are in discussions for an additional three potential reservations.
