- I. Call Meeting to Order Megan Hartline called the meeting to order at 5:05 p.m.

  - a. With the amended change of Kickoff Meeting Minutes date change to March 21, 2024.

- V. New Business Items
  - a. Study Session Debrief
    - Council Members reviewed the 2024 Study Session process.
      Areas of discussion go to Fall Retreat.
  - b. Funding Allocation Presentation Megan Hartline

- i. Considerations:
  - 1. Adams County requests for funding were higher than funding available.
  - 2. Map funding to Council's tiered scores for applicants.
  - 3. Tiered funding percentages for 2024/25 is lower than previous years.
  - 4. Evaluation of ineligible projects:
    - Adams County Historical Society, RecTrac Payment System. Reason: SCFD funds cannot be used for capital purchases.
    - b. Aurora Symphony Orchestra, Pilot Project of "Carousel". Reason: Project outside of 2024/25 date range.
    - c. Commerce City Cultural Council, Music in the Park. Reason: application error.
    - d. Denver Philharmonic Orchestra, Outreach through Mapleton Arts Center. Reason: Incomplete application.
    - e. Thornton Community Band, TCB Student Instrument Step Up. Reason: SCFD funds cannot be used for scholarships.
- ii. Two funding models presented for approval:
  - a. Model #1: Excludes all 5 projects deemed ineligible
  - b. Model #2: Includes project disqualified due to date error; rated as "fair"
  - 1. Motion made to approve Funding Model #2 by Jim Towle, seconded by Jesse Martinez; Seven in favor, one opposed. Motion passed.
- c. Looking Forward: 2025 Guidelines
  - i. The Cultural Council will form a subcommittee to review County Guidelines. Subcommittee to meet over the summer and propose changes to 2025 Guidelines at the Fall Retreat.
    - 1. Subcommittee Council Members: Joyce Downing, Jim Towle, Megan Hartline; SCFD Program Officer, Dana Manyothane; Adams County Staff, Zoe Ocampo
- VI. SCFD Updates Dana Manyothane
  - a. SCFD board meeting 5/23: Tier I's presented; on way to full recovery to pre-covid.
  - b. The March 2024 SCFD sales and use tax revenue was \$7,061,160.43. The 2024 year-to-date (YTD) sales and use tax revenue is \$19,570,013.62. This compares to the YTD 2023 sales

- and use tax revenue of \$19,916,218.87. The variance is (\$346,205.25), a 1.74% decrease in YTD 2024 over YTD 2023.
- c. Reauthorization SCFD Board voted at April meeting to get on the ballot in 2028.
- d. Reminder for Wednesday, June 5<sup>th</sup> Block Party and Rex Morgan Awards. Open to all SCFD organizations.
- e. Council Chairs & Liaison meeting June 13 at Wonderbound.
- f. Friday, October 11 is the deadline for 2025 Guidelines from Councils
- g. Tier III award checks distributed mid-October.
