

Funding Proposal Request for Applications

Deadline to Submit: July 1, 2024, at 12pm.

ACCMP Mission

To support children, youth, and families in Adams County with a partnership that is focused on prevention, intervention, elevating family voices, and streamlining access to community resources.

Requestor Requirements

- 1. Complete the online <u>Funding Proposal Form</u>
- 2. Submit any collateral documentation or attachments via email to mhynes2@adcogov.org
- 3. The proposals can fund new or existing programs but must meet criteria delineated in the Colorado Revised Statutes, Volume VII Rules, ACCMP Bylaws, and ACCMP Memorandum of Understanding.
- 4. The proposals must be targeted toward Adams County children/youth and comply with State required data-tracking and demographics (HB23-1249), which may include: first name, last name, date of birth, gender, race/ethnicity, zip code, disability status, victim status, and referral source must be entered, into the database. CMP sites are also required to collect and report data on CMP ISST clients' recommended services and a description of outcomes for children served as well as including a description of the services that were recommended but not provided and a description of the barriers to providing such services (OM-DCP-2024-0001).
 - a. Data reporting is required at least quarterly, specifics will be determined following award notice.
 - b. Proposals must be completed within a 12 month period.
- 5. Proposals must provide
 - The estimated number of children/youth to be served
 - Problem Statement (What is the community need this proposal/program is attempting to solve?)
 - Program Description (Demonstrate how the program will support CMP's goals. Inclusion of evidence-based data/interventions are strongly encouraged)
 - Collaborative Partners (Which agencies/programs will be collaborating in this proposal?)
 - Budget (Provide a description and formula for determining the costs)
 - Sustainability (How will this be sustained once funds are no longer available? What is the plan for funding this proposal if the ACCMP does not approve it?)
 - Evaluation Efforts (How will success be measured?)

Proposal Evaluation Criteria

All Proposals will be reviewed by ACCMP Inter-agency Oversight Group Members and evaluated as follows against the following criteria and programmatic alignments:

Evaluation:

(1 Does Not Meet Criteria, 2 Minimally Addressed Criteria, 3 Met Some but Not All Identified Criteria, 4 Addressed Criteria but Not in Thorough Detail, 5 Met All Criteria with High-Quality Detail)

ACCMP Mission Alignment:

To support children, youth, and families in Adams County with a partnership that is focused on prevention, intervention, elevating family voices, and streamlining access to community resources.

Strategic Goal Alignment:

GOAL 1: Identify key stakeholders and determine leverage points and linkages that would aid the ACCMP's progress to advance its mission.

GOAL 2: Develop and implement a robust continuous improvement plan (CQI) that is data-driven and youth/family/community informed.

GOAL 3: Increase the engagement of family members and youth to improve the ACCMP.

GOAL 4: Increasing the percentage of youth and families receiving quality care coordination.

GOAL 5: Establish infrastructure to grow and increase the efficiency and effectiveness of the ACCMP.

CMP Statute - Colorado Revised Statutes (C.R.S.) Alignment:

- 24-1.9-104(3)(a) "...The incentives shall be used to provide services to children and families who would benefit from integrated multi-agency services, as such population is defined by the memorandum of understanding..."
- 24-1.9-102 (h) "...any state general fund money appropriated to the program to be used to provide services to children and families who would benefit from integrated multi-agency services..." (referring to the reinvestment of money saved)

CMP Rule - Section 12 Code of Colorado Regulations (C.C.R.) Volume VII Alignment:

Prevention Programs are defined in 7.303.33 (B)(2): "CMP prevention programs must demonstrate
a multi-systemic approach. Programs must demonstrate in the MOU that multiple disciplines were
involved in the development or enhancement of the program or that multiple agencies are involved
in the delivery of the service."

CMP MOU (Section VI, Reinvestment of Funds Saved:

- ACCMP has established a procedure to allow funds received by the CDHS, and allocated pursuant to CRS 24-1.9-104, to be reinvested by the Parties to provide appropriate services to children and families who would benefit from multi-agency services has been approved by the head or director of each Party, as documented in the By-Laws Article XII.
- The Parties agree by signing this MOU that the ACCMP will review the CMP budget regularly to
 ensure that CMP funds are being used to serve children, youth and families that are involved in
 multiple systems or at risk of involvement in multiple systems. This includes funds being used to
 serve children, youth and families who are part of an ISST, CMP prevention program or as a
 mechanism to increase collaboration among Parties.

Attend the ACCMP IOG Meeting on July 9, 2024, from 2pm-4pm at the Adams County Human Services Center to answer questions.

ACCMP Review Committee submits evaluations and recommendations of funding proposals to the ACCMP IOG by July 18, 2024, by 11:59pm.

ACCMP IOG partner agencies submit recommendations for funding August 4, 2024, by 11:59pm.

ACCMP Executive Committee reviews evaluation results and selects funding recipient(s) on August 7, 2024.

Funding award notifications to the recipient(s) by 5pm on August 8, 2024.
