## Elevate People

#### **BAYAUD PARTNERSHIP**



Community Safety & Well-Being (CSWB) works with Bayaud Enterprises to operate mobile showers and mobile laundry units for residents experiencing homelessness. These units operate twice a week in

Adams County: Mondays at the Human Services Center and Thursdays at the Crossroads Community Center. From January through June 2024, 83 showers were provided to 45 unique individuals and 322 loads of laundry were done for 48 unique individuals.



#### **EVICTION DASHBOARD**

Adams County has a partnership with the Colorado State Courts to receive data on eviction filings and judgements. An eviction can have a huge impact on someone experiencing housing instability both financially and mentally. But what are those specific financial effects? Are different areas of Adams County effected differently? This tool allows for exploration into the different types of evictions, areas that experience the most evictions, and the financial impacts they can impose on a resident.



Zip code 80229 has more than 12,000 evictions since 2011 and averages 250-300 evictions every quarter.

### **SUMMER SWAP ACTIVATIONS**

The Severe Weather Activation Program (SWAP) summer hotel rooms are available for Adams County participants only when temperatures reach 98F or above two days consecutively regardless of precipitation. Hotel vouchers will be distributed through outreach workers in Adams County to their active clients. In June, SWAP helped to avert 174 nights of unsheltered homelessness.

### TREE DISTRIBUTION


Neighborhood Services, in collaboration with Public Works, Parks, Open Space & Cultural Arts, and Groundwork Denver, distributed 99 trees spanning 11 different species to residents of the Commerce City/Dupont neighborhood.

#### **BLOOD-SPORT RING BUST**

In collaboration with the Adams County Sheriff's Office, CSWB Animal Management safely rescued more than 100 chickens used in blood-sports. Working in collaboration with the Riverdale Animal Shelter and Adams County Sheriff's Office, we were able to get 106 of said chickens adopted and housed.

#### **ACT PROGRAM UPDATE**


The ACT pilot program provides education, outreach, and collaboration regarding Adams County Development Standards and Regulations to industrial/commercial businesses along an identified portion of the Federal Corridor. Cases enter the maintenance phase when they have no violations identified on their property during two consecutive, onsite inspections.

## **PROJECT GROW**



On May 17, Project Grow successfully planted its newest garden in collaboration with Gateway Shelter. The garden will provide fresh produce to the shelter's residents. A comprehensive effort was undertaken by the team via installing state of the art farming techniques & technology. The project was a combined effort, with CSWB employees Joe Camacho, Corbin Hamilton, and Rachel Jakubowski playing key roles in the installation and volunteers from Gateway assisting. This garden will help to put a dent in food insecurity among Adams County's underserved residents and will serve as an educational tool for all.
