ADAMS COUNTY, COLORADO SERVICE AGREEMENT

THIS AGREEMENT ("Agreement") is made this 15 day of 1010 day, 2012, by and between the Adams County Board of County Commissioners, located at 4430 South Adams County Parkway, Brighton, Colorado 80601, hereinafter referred to as the "County," and, Stream Design LLC located at 3330 Larimer Street, Unit 1b, Denver, Colorado 80205 hereinafter referred to as the "Consultants." The County and the Consultants may be collectively referred to herein as the "Parties".

The County and the Consultants, for the consideration herein set forth, agree as follows:

SECTION I - SERVICES OF THE CONTRACTOR

The Consultants shall provide design improvements services for Rotella Park consistent with the Rotella Park Renovation Master Plan of December 2008. The services described must be in accordance with the requirements of the Request for Proposal attached hereto as Exhibit "A"., and the Consultant's proposal response dated May 8, 2012, attached hereto as Exhibit "B.

Emergency Services In the event the Adams County Board of County Commissioners declares an emergency, the County may request additional services (of the type described in this Agreement or otherwise within the expertise of Consultant) to be performed by Contractor. If County requests such additional services, Consultant shall provide such services in a timely fashion given the nature of the emergency, pursuant to the terms of this Agreement. Unless otherwise agreed to in writing by the parties, Consultant shall bill for such services at the rates provided for in this Agreement.

SECTION II - COMPLIANCE WITH C.R.S. § 8-17.5-101, ET. SEQ. AS AMENDED 5/13/08

Pursuant to Colorado Revised Statute (C.R.S.), § 8-17.5-101, et. seq., as amended 5/13/08, the Contractor shall meet the following requirements prior to signing this Agreement (public contract for service) and for the duration thereof:

- A. The Contractor shall certify participation in the E-Verify Program (the electronic employment verification program that is authorized in 8 U.S.C. § 1324a and jointly administered by the United States Department of Homeland Security and the Social Security Administration, or its successor program) or the Department Program (the employment verification program established by the Colorado Department of Labor and Employment pursuant to C.R.S. § 8-17.5-102(5)) on the attached certification.
- B. The Contractor shall not knowingly employ or contract with an illegal alien to perform work under this public contract for services.

- C. The Contractor shall not enter into a contract with a subcontractor that fails to certify to the Contractor that the subcontractor shall not knowingly employ or contract with an illegal alien to perform work under this public contract for services.
- D. At the time of signing this public contract for services, the Contractor has confirmed the employment eligibility of all employees who are newly hired for employment to perform work under this public contract for services through participation in either the E-Verify Program or the Department Program.
- E. The Contractor shall not use either the E-Verify Program or the Department Program procedures to undertake pre-employment screening of job applicants while this public contract for services is being performed.
- F. If Contractor obtains actual knowledge that a subcontractor performing work under this public contract for services knowingly employs or contracts with an illegal alien, the Contractor shall: notify the subcontractor and the County within three days that the Contractor has actual knowledge that the subcontractor is employing or contracting with an illegal alien; and terminate the subcontract with the subcontractor if within three days of receiving the notice required pursuant to the previous paragraph, the subcontractor does not stop employing or contracting with the illegal alien; except that the contractor shall not terminate the contract with the subcontractor if during such three days the subcontractor provides information to establish that the subcontractor has not knowingly employed or contracted with an illegal alien.
- G. Contractor shall comply with any reasonable requests by the Department of Labor and Employment (the Department) made in the course of an investigation that the Department is undertaking pursuant to the authority established in C.R.S. § 8-17.5-102(5).
- H. If Contractor violates this Section II of this Agreement, the County may terminate this Agreement for breach of contract. If the Agreement is so terminated, the Contractor shall be liable for actual and consequential damages to the County.

SECTION III - RESPONSIBILITIES OF THE COUNTY

The County shall provide information as necessary or requested by the Consultants to enable the Consultant's performance under this Agreement.

SECTION IV - TERM

The term of this Agreement shall commence upon receipt of Notice to Proceed and be completed by September 30, 2012.

SECTION V - PAYMENT AND FEE SCHEDULE

The County shall pay the Consultants for services furnished under this Agreement, and the Consultants shall accept as full payment for those services, the sum of forty-nine thousand two hundred and thirty dollars (\$49,230.00).

A. Invoices

Invoices will be submitted to the County by the Consultants on a monthly basis for services performed under this Agreement. Payment of the invoices by the County will be made within twenty-five (25) days of the receipt thereof.

B. Fund Availability

The County has appropriated sufficient funds for this Agreement for the current fiscal year. Payment pursuant to this Agreement, whether in full or in part, is subject to and contingent upon the continuing availability of County funds for the purposes hereof. In the event funds become unavailable, as determined by the County, the County may immediately terminate this Agreement or amend it accordingly.

SECTION VI - INDEPENDENT CONTRACTOR

In providing services under this Agreement, the Consultants act as an independent contractor and not as an employee of the County. The Consultant shall be solely and entirely responsible for his/her acts and the acts of his/her employees, agents, servants, and subcontractors during the term and performance of this Agreement. No employee, agent, servant or subcontractor of the Consultants shall be deemed to be an employee, agent or servant of the County because of the performance of any services or work under this Agreement. The Consultants, at its expense, shall procure and maintain workers' compensation insurance as required by law. Pursuant to the Workers' Compensation Act § 8-40-202(2)(b)(IV), C.R.S., as amended, the Contractor understands that it and its employees and servants are not entitled to workers' compensation benefits from the County. The Contractor further understands that it is solely obligated for the payment of federal and state income tax on any moneys earned pursuant to this Agreement.

SECTION VII - NONDISCRIMINATION

The Consultants shall not discriminate against any employee or qualified applicant for employment because of age, race, color, religion, marital status, disability, sex, or national origin. The Consultants agrees to post in conspicuous places, available to employees and applicants for employment, notices provided by the local public agency setting forth the provisions of this nondiscrimination clause.

SECTION VIII - INDEMNIFICATION

The Consultants agrees to indemnify and hold harmless the County, its officers, agents, and employees for, from, and against any and all claims, suits, expenses, damages or other liabilities, including reasonable attorney fees and court costs, arising out of damage or injury to persons, entities, or property caused or sustained by any person(s) as a result of the Consultant's negligent performance or failure to perform pursuant to the terms of this Agreement or as a result of any subcontractors' negligent performance or failure to perform pursuant to the terms of this Agreement.

SECTION IX - INSURANCE

The Consultants agrees to maintain insurance of the following types and amounts:

<u>Commercial General Liability Insurance</u>: to include products liability, completed operations, contractual, broad form property damage and personal injury.

Each Occurrence General Aggregate \$1,000,000 \$2,000,000

<u>Comprehensive Automobile Liability Insurance</u>: to include all motor vehicles owned, hired, leased, or borrowed.

Bodily Injury/Property Damage Personal Injury Protection

\$1,000,000 (each accident)
Per Colorado Statutes

Workers' Compensation Insurance:

Per Colorado Statutes

* <u>Professional Liability Insurance</u>: to include coverage for damages or claims for damages arising out of the rendering, or failure to render, any professional services.

Each Occurrence

\$1,000,000

* This insurance requirement applies only to Consultants who are performing services under this Agreement as professionals licensed under the laws of the State of Colorado, such as physicians, lawyers, engineers, nurses, mental health providers, and any other licensed professionals.

The Consultant's commercial general liability, comprehensive automobile liability, and professional liability insurance policies and/or certificates of insurance shall be issued to include Adams County as an "additional insured," and shall include the following provisions:

- 1. Underwriters shall have no right of recovery or subrogation against the County, it being the intent of the parties that the insurance policies so affected shall protect both parties and be primary coverage for any and all losses resulting from the actions or negligence of the Consultants.
- 2. The insurance companies issuing the policy or policies shall have no response against the County for payment of any premiums due or for any assessments under any form of any policy.
- 3. Any and all deductibles contained in any insurance policy shall be assumed by and at the sole risk of the Consultants.

All insurers of the Consultants must be licensed or approved to do business in the State of Colorado. Upon failure of the Consultants to furnish, deliver and/or maintain such insurance as provided herein, this Agreement, at the election of the County, may be immediately declared suspended, discontinued, or terminated. Failure of the Consultants in obtaining and/or maintaining any required insurance shall not relieve the Consultants from any liability under this Agreement, nor shall the insurance requirements be construed to conflict with the obligations of the Consultants concerning indemnification.

Each insurance policy herein required shall be endorsed to state that coverage shall not be suspended, voided, or canceled without thirty (30) days prior written notice by certified mail, return receipt requested, to the County.

At any time during the term of this Agreement, the County may require the Consultants to provide proof of the insurance coverages or policies required under this Agreement.

SECTION X - TERMINATION

A. For Cause

If, through any cause, the Consultants fails to fulfill its obligations under this Agreement in a timely and proper manner, or if the Consultants violates any of the covenants, conditions, or stipulations of this Agreement, the County shall thereupon have the right to immediately terminate this Agreement, upon giving written notice to the Consultants of such termination and specifying the effective date thereof.

B. For Convenience

The County may terminate the Agreement at any time by giving written notice as specified herein to the other party, which notice shall be given at least thirty (30) days prior to the effective date of the termination. If the Agreement is terminated by the County, the Consultants will be paid an amount that bears the same ratio to the total compensation as the services actually performed bear to the total services the Consultants was to perform under the Agreement, less payments previously made to the Consultants under the Agreement.

SECTION XI - MUTUAL UNDERSTANDINGS

A. <u>Jurisdiction and Venue</u>

The laws of the State of Colorado shall govern as to the interpretation, validity, and effect of this Agreement. The parties agree that jurisdiction and venue for any disputes arising under this Agreement shall be with the 17th Judicial District, Colorado.

B. Compliance with Laws

During the performance of this Agreement, the Consultants agrees to strictly adhere to all applicable federal, state, and local laws, rules and regulations, including all licensing and permit requirements. The parties hereto aver that they are familiar with § 18-8-301, et seq., C.R.S. (Bribery and Corrupt Influences), as amended, and § 18-8-401, et seq., C.R.S. (Abuse of Public Office), as amended, and that no violation of such provisions are present. Contractor warrants that it is in compliance with the residency requirements in §§ 8-17-101, et seq., C.R.S. Without limiting the generality of the foregoing, the Consultants expressly agrees to comply with the privacy and security requirements of the Health Insurance Portability and Accountability Act of 1996 (HIPAA) when exposed to or provided with any data or records under this Subcontract that are considered to be "Protected Health Information."

C. Record Retention

The Consultants shall maintain records and documentation of the services provided under this Agreement, including fiscal records, and shall retain the records for a period of three (3) years from the date this Agreement is terminated. Said records and documents shall be subject at all reasonable times to inspection, review, or audit by authorized federal, state, or county personnel.

D. Assignability

Neither this Agreement, nor any rights hereunder, in whole or in part, shall be assignable or otherwise transferable by the Consultants without the prior written consent of the County.

E. Waiver

Waiver of strict performance or the breach of any provision of this Agreement shall not be deemed a waiver, nor shall it prejudice the waiving party's right to require strict performance of the same provision, or any other provision in the future, unless such waiver has rendered future performance commercially impossible.

F. Force Majeure

Neither party shall be liable for any delay or failure to perform its obligations hereunder to the extent that such delay or failure is caused by a force or event beyond the control of such party including, without limitation, war, embargoes, strikes, governmental restrictions, riots, fires, floods, earthquakes, or other acts of God.

G. Notice

Any notices given under this Agreement are deemed to have been received and to be effective: (1) three (3) days after the same shall have been mailed by certified mail, return receipt requested; (2) immediately upon hand delivery; or (3) immediately upon receipt of confirmation that a facsimile was received. I. <u>Severability</u>

If any provision of this Agreement is determined to be unenforceable or invalid for any reason, the remainder of this Agreement shall remain in effect, unless otherwise terminated in accordance with the terms contained herein.

J. <u>Authorization</u>

Each party represents and warrants that it has the power and ability to enter into this Agreement, to grant the rights granted herein, and to perform the duties and obligations herein described.

SECTION XII - CHANGE ORDERS OR EXTENSIONS

- A. The County may, from time to time, require changes in the scope of the services of the Consultants to be performed herein including but not limited to additional instructions, additional work, and the omission of work previously ordered. Such changes, including any increases or decreases in the amount of the Consultants compensation, must be mutually agreed upon in writing by the County and the Consultants. The Consultants shall be compensated for all authorized changes in services, pursuant to the applicable provision in the Invitation to Bid, or, if no provision exists, pursuant to the terms of the Change Order.
- B. The County may, upon mutual written agreement by the parties, extend the time of completion of services to be performed by the Consultants.

SCOPE OF WORK

INTRODUCTION AND BACKGROUND

Rotella Park is a 37 acre park owned by Adams County. The County acquired the land in 1972 and since that time developed and maintained Rotella as a popular destination. The Park currently provides a variety of recreational activities, such as open lawn for Frisbee or soccer, a basketball court, sand volleyball courts, play structures for children, picnic shelters with barbeque grills for families, a pond for fishing and wildlife watching and paved trails for walking and jogging. The irrigation system in the Park was replaced approximately 10 years ago and much of the system is still in good condition. The system uses raw water from the Oliver Ditch and when ditch water is not available, domestic water from a 3" tap.

PROJECT GOALS

- The project consists of the services necessary to design improvements consistent with the Rotella Park Renovation Master Plan of December 2008.
- Correct poor drainage conditions existing around the two gravel parking lots, and low lying turf areas.
- Eliminate, reorganize, repair, modify and/or replace outdated components, including parking lots, shelters, park furniture, landscape features, plant materials, irrigation systems, play areas, hard surfaces, signage, restrooms, access/egress and courts of park.
- Interface existing irrigation system when possible.
- Develop CD's for phased implementation.

LOCATION

Rotella Park is located at 2224 Coronado Parkway South, Denver, CO 80229.

SCOPE OF SERVICES

- Produce complete construction documents and specifications for the County to advertise for construction bids. All drawings and specifications shall be stamped by a licensed landscape architect and licensed engineer.
- After bid award, the Design Team shall attend a project kickoff meeting with Adams County Parks staff for preliminary discussions concerning project design development, phasing, scheduling and construction plans.
- The Design Team shall provide design/engineering services necessary to
 produce and deliver bid and construction documents for Rotella Park
 renovations, consistent with the created and adopted Master Plan; utilizing the
 conceptual ideas and plans provided in the <u>master plan</u> and <u>grant submittal</u>
 documents for the Park, within the approved budget and required time schedule,
 (materials will be available to bidders for consideration).

- Provide Construction Documents that include: technical specifications, grading plan(s), drainage plan, storm-water plan, landscape plan, irrigation plan, and all other details/plans required for permitting submittals and bid estimation by landscape construction contractor(s).
- Design team will need to work closely with Adams County Public Works/Engineering Department for the drainage improvements and parking lot access points/curb cut(s) onto Coronado Parkway.
- Design team will provide project design survey (horizontal, vertical and underground utilities) will be included in the design services.
- Meet with the County Project Staff for preliminary discussions concerning project design development, phasing and construction plans.
- Adams County Park standards for park signage and shelters shall be used for the project, as specified in the Master Plan. Adams County shall supply the Consultant with a hardcopy of the standard sign design.
- The Design Team will provide a progress schedule and conduct data gathering meetings, as necessary, or at minimum meet with the Adams County Project Manager bi-monthly.
- The Design Team shall be required to contact the Utility Notification Center for utility marking, and shall review as necessary with Xcel Energy, United Power, Centurylink Communications, Comcast, AT&T, Colorado Agricultural Ditch Company, petroleum companies, other applicable utilities, and other private utility provider maps, as required, to accurately depict existing utility locations, depths and points.
- Design team will develop quantity estimates and independent professional construction cost estimates for the total project, including construction management services to be included in base bid for by the Design Team (see construction support services).
- Provide and pay for all printing and reproduction of all drawings and specifications until construction drawings are ready for bidding. Provide electronic plans and specifications for reproduction. Adams County will provide all reproduction of contract documents for bidding and construction.
- The Design team will be required to meet no less than bi-monthly with the County Project Management staff during the design period. The design team manager and other appropriate design professionals are expected to attend such meetings. Additional project meetings will be scheduled as needed. Also, additional evening project presentation meeting with the public should be assumed.

CONSTRUCTION SUPPORT SERVICES

In addition to specific construction support services requested from certain disciplines or outlined in the Agreement provisions, the following general services are to be provided by the design team.

Attend a mandatory pre-bid meeting by landscape construction bidders.







APPROACH

Rotella Park is a wonderful park. The undulating grassy meadows, mature vegetation, fishing pond, active picnic areas, and great views provide a complete park experience for visitors. The Park feels like a true "oasis in the City," and a walk around the park makes a visitor feel like they have had a brief escape to the country. While the park needs some structure replacements and updating, it has good bones that can continue to be the framework for future improvements for many years. The Stream Design team feels that the implementation of the master plan should build on the park's great sense of escape and natural wonder by designing improvements that build on the special qualities of the park while accomplishing the necessary functional upgrades and maintenance improvements.

The following are some key issues that will need to be successfully addressed by the team:

1. Strategize to Achieve Cost Savings on Pre-Designed Items It will be a challenge to achieve all of the improvements proposed in the master plan with the budget that has been laid out in the plan's cost estimate. Key cost items like contractor mobilization, demolition of existing features to be replaced, earthwork, curb and gutter, drainage structures, and irrigation system modifications have been omitted from the cost estimate, and are not going to be covered by the estimate's 10% contingency. So in order to meet the desired improvement expectations, it will be necessary to creatively strategize on cost saving measures. The Stream Design team has identified a significant cost saving opportunity in the method of procuring the picnic shelters and site furnishings. According to the master plan, the cost for the shelters and furnishings (picnic tables, benches, and trash receptacles) proposed for phases one and two would be almost \$400,000. The County could save a considerable amount of money--possibly up to 15% to 20%-- on these items if they are purchased by the County instead of by the




Shelters and site furnishings make up almost 40 percent of the estimated costs for the master plan implementation. A pre-purchase by the county can save tens of thousands of dollars on construction costs.

contractor. The Contractor would generally apply a significant markup, which, if eliminated, could amount to as much as \$80,000 in savings over both phases. The installation of the shelters would then be bid by the Contractor as a unit cost bid item. We have recently had a good experience pursuing this strategy for the Kennedy Dog Park in the City of Denver. In this case the foundation designs for the shelters were also wrapped into the 'installation' bid item, as this work is generally done more cheaply by the shelter supplier's engineers than if it were designed by the consultant team. Further savings can be achieved if easy-to-

install items like benches, picnic tables and trash receptacles are also pre-purchased by the County, and then installed by County maintenance staff. These and other options will be addressed early on in the process during Stream Design's interviews with County management and design staff.

2. Develop Multi-Use Drainage Improvements:

The solution to the drainage issues along the north side of the park should be cost effective, and should add value to the park beyond basic drainage improvements. Our site investigations have found that the top of curb along Coronado Parkway is approximately 8 to 15 inches higher than the lowest turf areas along the northern park edge, which creates the sump area where drainage issues persist. Getting positive sheet drainage to Coronado Parkway would be not possible without



A drainage swale along the poorly drained buffer strip along Coronado Parkway can solve drainage problems and provide other park functions without requiring significant changes to the park. The swale preserves existing trees and adds new trees and shrubs as enhancements; picks up drainage from poorly draining areas in french drain "laterals"; drains into a storm pipe, and then into existing pipe under Coronado; and picks up drainage from primary parking lot landscape swale.

major impacts to the park, and would require raising the main east-west trail, regrading of the area between the path and the parkway, and the subsequent need for re-sodding and irrigation modifications that would ensue. This solution is not recommended option due to the high cost and impacts to existing trees and features. A better solution is to create a drainage feature parallel to Coronado Parkway through the lowest / poorest draining areas that would collect stormwater and convey it from west to east, with "lateral" drainage lines (or french drains) that could drain isolated problem drainage areas and tie into the main drainage swale/feature. This design element could also serve as a barrier to vehicular traffic entering the park area off of Coronado Parkway, which has been identified as a a problem in the master plan. It could be locaated to wind around (and preserve) existing trees, and could be lined with boulders and planted with shrubs, and trees, to create a wonderful park amenity.

Other design opportunities present themselves at the Primary Parking Lot, where stormwater flowing off of the asphalt surface could be directed to widened landscape medians that can and convey it in a grass swale to storm pipes that connect to the main detention area while irrigating plant material, infiltrating water into the soil, and settling out the larger sediment and pollutants. While a detention pond would still

Parking lot medians can convey runoff, provide water quality, and irrigate trees, as this one does at Lowry Court Sports, designed by Stream Design staff. be needed to comply with Adams County requirements, the pond can be sized up to 20 % small based on the credits that are achieved by using grass swales, etc.

3. Maximizie ADA Accessibility

As the park was built prior to the ADA act of 1991, some of the main pathways in the park exceed maximum slope requirements. (SEE DIAGRAM BELOW). In particular, the walkways leading up to the fishing pond from the east, the paths that provide access to the children's adventure garden, and the path that continues up the hill from the



Trail segments shown in red exceed ADA guidelines for slope. Minor grading adjustments can help to bring most of these areas into compliance.

children's adventure garden to the hilltop play/sculpture area, all slope from 7 to 8 percent for relatively short reaches. With minor modifications these paths can be made ADA compliant, providing valuable universal access to the unique attractions of the pond and the adventure garden. While the adventure garden itself does not need to be completely accessible, a significant portion of it will need to comply with ADA access requirements, as must the playground expansion on the northeast side, and the tot lot on the northwest side. The most difficult trail to make accessible is the segment south of the adventure garden. Since this trail does not provide access to a park element that is anticipated to be improved or modified as part of Phase 1 or Phase 2, it would be possible to delay any action on making it accessible until a later phase. However the other trails do provide access to unique park elements / experiences (the pond and the adventure garden) that are close to the proposed new/expanded parking secondary parking lot, and will likely need to be made accessible.

The Stream Design team members have had extensive experience in

both the design of new ADA accessible facilities, and with the updating of existing, out-of-compliance facilities, and will be able to assist the County in "surgically" improving the existing pathways to avoid major allocations of budget to this unplanned scope item.

4. Create picnic areas with a sense of place

Although the existing picnic shelters are in poor condition and are susceptible to vandalism, their design helps to create a comfortable environment for picnickers due to their balance of enclosure and openness. This is important, especially for the picnic areas near the northeast parking lots, which are tightly clustered, and have a lot of people filtering through on their way between the parking lot and the playground and basketball courts. People within the picnic shelters feel comfortable due to the definition of space around the shelters that clearly defines the picnic space, and differentiates it from the space that visitors pass through. Much of this sense of enclosure comes from the central chimney and while the new shelters will obviously not have chimneys, the incorporation of other elements, like benches, low seat walls, and even shrub planting beds, will be important to help create a similar sense of place and spatial definition in the new picnic areas. On the other hand it will also be important to create strong pedestrian connections between the parking lot and the activity areas, so that the picnic areas are better separated from the pass-through traffic, allowing picnickers a little more "private" space.



Shelters with spatial enclosure such as that provided by the seat wall in this shelter in Jefferson County's Flying J Ranch Park p,rovide more comfortable spaces for picknicers, especially in areas with lots of adjacent foot traffic, such as near the primary parking lot.


5. Meet the Aggressive Schedule for Construction


As the schedule on page 8 illustrates, there are only 8 weeks of "design time" to get from project start-up to the 90% submittal to meet the mandate of a bid set by September. In addition to this, after the final County review, we have allotted one extra week for final revisions and response to County comments. All in all the schedule is very tight, and will require the design team and County staff to work together to facilitate quick decision-making in a timely manner. To expedite the process we have proposed performing preliminary design using scaled aerial photos at the beginning of the design phase, as survey generally takes at least two weeks form notice to proceed to get completed. We are also proposing an advisory meeting with the County reviewers during the Alternatives Development phase to present the project's main objectives and get recommendations on how to best navigate the development review system with a minimum of surprises at the end.


DESIGN TEAM PROJECT INFORMATION:

Parkfield Lake Park, Denver, Colorado

Parkfield Lake Park is a Denver's newest and most dynamic Community Park. Complementing the adjacent Parkfield Lake, and Parkfield Recreation Center, this 35-acre park provides a wide range of recreational opportunities for the Parkfield and Montbello neighborhoods in Denver. Amenities include picnic areas, natural and artificial turf sports fields, tournament-grade basketball courts, a skate park, a lake-side amphitheater, a dog park, natural areas, and the City of Denver's largest playground / spray-ground. A natural drainage infrastructure system uses site runoff to create a naturally irrigated, sinuous natural corridor while providing water quality treatment for site stormwater. Parking lots are built with landscape detention and water quality in the medians, eliminating the need for separate water quality treatment ponds. Project completed in 2011.








Lowry Court Sports, Denver, Colorado







Assumptions:

- 1. Improvements will generally follow the Rotella Park Master Plan of 2008.
- 2. Survey will be performed for for general area of the Phase 1 and Phase 2 improvements only, as described in Addendum #4.
- 3. Playground work includes expansion of existing playground to include tot elements and tricycle path (estimated cost \$50,000) and a new tot lot near the new picnic areas on the northwest side of the park (estimated cost \$50,000).
- 4. Stormwater management permit to be obtained by the contractor.
- 5. Picnic shelters to be pre-designed and pre-engineered catalogue items. Foundation designs to be provided by the contractor. Contractor shall be required to submit engineered show drawing for the foundations stamped by an engineer licensed in the State of Colorado.
- 6. "Restrooms" described in the RFP shall be enclosures for portable toilets. No water or sanitary utilities are included in the scope.
- 7. Drinking fountains are excluded from the scope per Addendum #4.
- 8. Electrical services and lighting are excluded from the scope per Addendum #4.
- 9. Public meetings and presentations to County or other agencies are not included in the scope. If these meetings become necessary, Stream Design shall require payment for time and materials, based on our standard hourly rates to prepare for and attend meetings.
- 10 .4 borings will be performed for geotechnical information upon which to base pavement designs for the parking lots, and the shelters near each parking lot. The team geotechnical engineer will provide paving recommendations for the parking areas.
- 11. Construction period services are included for Phase 1 only (as described in Addendum #4). Construction observation services assume ap proximately 44 hours of total services by the Stream Design team, and assumes that the County will be the main contact with the Contractor, and will provide primary oversight on the project. Stream Design's involvement will be to verify that the intent of the design is being carried out. No materials testing is included in this scope.
- 12. It is assumed that no 404 Permitting (for impacts to wetlands and/or waters of the US) will be required with the US Army Corps.





Schedule Assumptions:

- 1. Two review submittals are assumed to the County, per Addendum #4. These reviews are assumed to require 3 weeks (also per Addendum #4)
- 2. Consultant selection schedule is estimated for purposed of planning potential start of project only.
