

Kiowa Creek Airsoft & Paintball LLC, comprises of Owner Kevin Mitchell, Manager Sean Galloway and Manager Ross Kortgardner. Ross Kortagardner and Sean Galloway have spent many years both participating, organizing, and managing the sport of Paintball & Airsoft across the country. Kevin Mitchell, is the owner Kiowa Creek and has operated the business for many years in Bennett, CO. Our Goals for the business is to grow both Paintball and Airsoft in the region and provide a fun and safe location for participants to play in a controlled environment.

We want to bring a unique experience to the Airsoft and Paintball community at the Kiowa Creek Location in Bennett Colorado. We believe that this location will bring that experience, and excitement. We can see the potential business growth for local commerce, restaurants chains, and small businesses in the city of Bennett. To achieve this goal we want to grow our business from the current 50 or less participants to 100-200 participants per week. We believe this goal is easily achievable with what this location provides.

Kiowa Creek Airsoft and Paintball is located at 49100 Old Victory Rd. in Bennett, CO. and is open from 9am to 5pm Saturdays and Sundays throughout the year. The facility consists of a small office for players to register for the day, a small storage shed that holds necessary equipment and props to use to create a unique experience for the participants. There is a large parking lot for participants to prepare in between games. The Parking lot, Storage shed and office is separated from the field by a safety boundary and large netting designed to stop paintballs and bbs from entering the parking area. There are boundaries approximately 100 ft away from the Union Pacific Railroad, and another across Kiowa Creek boarding the Mitchell Family Trust. Another boundary is ½ mile south of Old Victory Rd. The field consists of 3 different fields equalling to about 80 acres consisting of two bases on either side with a small simulated village separating them. We can combine each field for large numbers of participants or we can use each individually. Kiowa Creek runs the length of the facility and is part of each field.

When People arrive they are required to go to the office and check in. There they can purchase rental equipment and needed supplies for the day. After they have registered they must attend a safety briefing to know and understand the rules of the field. Players who violate the rules will be escorted off the field and reprimanded for their actions. Either by being given a warning or by being ejected from the property depending on their violation. When players are ready they will be given a briefing about the game they are about to play and be escorted by a referee onto the field. When the game is finished they will be given an opportunity to prepare for the next game in the parking lot. This continues throughout the day until around 5pm when staff will clean up the field and parking lot to prepare for the next operating day.

We believe this is a great opportunity for Adams County, City of Bennett, and Kiowa Creek partners to provide the region an excellent and unique service to the community as well to the sports.

A. Tell us the anticipated number of employees onsite

• 4 employees to be onsite

B. Is there a central access/gate to the facility? How is Money Exchanged?

- 1 access from Old Victory Rd. Main road leading to facility is 2 cars wide.
- Money is exchanged at a front office/shop through a cash box and Square reader Credit card App



C. Are any buildings proposed for the operation?

- Currently we have storage shed, Office, and tools shed all custom built with locking doors (Images Below)
- We propose 2 conex storage containers, for office and storage use. It will look cleaner, more professional, secure and our main concern safety.



D. How do people find out about the business?

- Social networks such: Facebook, instagram, emails.
- Word of mouth, flyers, business cards

E. Please provide more information about the paintball course itself. How will it be set up, and how do people participate? Can multi groups participate at the same time in different areas?

- The course runs north to south roughly 80 acres split into 3 courses. Two dirt roads run down the length of the course for vehicle access. Throughout the course have various wood fences screwed together to form walls and mounted to 4x4 beams. Various entrenchments and dirt hills. 6 Village buildings made out milled lumber to create non livable buildings that can be moved throughout the course with heavy machinery. Various amount of vegetation and trees.
- Participants are split into teams, and start at different starting points on the field and try
 to complete objective discussed during briefing.
- Multiple groups and or private groups can use different sections for the course that are not being used led by a ref/employee

F. Is there a waiting period for people to get on the course if it is being used? What do people do while they are waiting for the course to clear? Is there shelter? How long do event last on the course.

- Participant must wait till the end of the round and the employee escorts them back onto the course
- Participants while waiting will be prepare gear and resources for the next game in the parking/staging area.
- Currently there are only 2 shelters available.
- We propose more shelter around the parking/staging area
- Average time on course is 20-30 minutes with 15 min breaks Operation times on the course is from 10am to 4pm with Lunch break

G. Describe how the business operates, how do people participate?

• We operate 1-2 day a week, Sat-Sun. 9am-4pm, Employees start by setting up the course for the day at 9am. Employees will open up the Office/Shop at 9:30am to have players sign waivers and purchase gear and rentals. At 10am Employees will give a mandatory safety meeting to go over rules and safety protocols. After the safety meeting players are required to have their gear checked by staff to properly ensure players are not breaking those safety protocols. Around 10:30 players are split into teams and informed about the rules of the game. Players then go to their respective starting locations and wait for game staff to start the game. When the game is over players can go back to the Parking/Staging Area to wait for the next game. At 12pm Players are given a break till 1pm. At 1pm players are required to have gear checked by staff to ensure safety protocols are being followed. Players are split into teams, go to their respective starting locations and wait for staff to start the game. At 4pm staff ends the game and players are required to leave the field. Staff clean up the course, office, shop, and parking lot of trash and gear, and then close.

H. Will there be a cap on the number of people allowed on the property at one time. How many people can participate at one time on the course?

- During normal operating weekends, non-special events weekends, we have a cap of 100 players. We have never gone over 100 players for a non-special event. We could go more if needed. For special events the cap is 250 players.
- All players can participate at the same time.

- I. Parking areas are required to be paved. Please justify the number of parking spaces you have planned. You state you anticipate approximately 50 participants a day or approximately 200 participants over a weekend. Can you explain how you arrived at these projections? The number of parking spaces you show would not be sufficient.
 - In addition to the parking lot we have a mowed field players can use for camping.
 - For non-special events parking has been sufficient enough to hold 50-60 players, most players car-pool.
 - For special events the field can be used for camping. Players usually park next to their campsites.
 - In the past few years we have had larger scale events that have reached 250 participants.
 - We have a minimum of 48 proposed parking spots.

J. Have you ever operated a paintball type business in the past? What experience do you have operating a business like this? Do you have any special training for running a business like this?

- Ross Kortgardner-Been in the Paintball Industry as a consultant and participant for over 20 years. I currently run an Airsoft Event entertainment company call JTAC Airsoft Productions LLC that has been in business for 4 years out of the State of Colorado. I have been working with the current Kiowa Creek staff for 5 years. I have developed ideas for the business and building the foundation of Kiowa Creek, through my experience and knowledge of this sport such as Community relations, product knowledge and development, industry safety procedures, and retail sales.
- Sean Galloway- 2 year paintball business experience. 6+ years Experience in fixing and building airsoft guns and as a participant.

K. What types of safety and emergency protocols do you have in place should there be an accident? What are your emergency contingencies? What happens if a storm event occurs?

- We have an emergency vehicle access point on the south side of the course. This has been used by local firefighters and law enforcement.
- When there is an emergency, players are escorted off the field.
- If there is a medical emergency Staff are to grab the first aid kit from the office. Certified
 first-aid responders are called to the scene of the emergency. Many of our players are
 first-aid certified or work in the emergency medical field. If the emergency is lifethreatening or severe, emergency services are called and directed to the access point to
 address the situation.
- If it is a fire, Emergency fire service are called and escorted to the fire.
- When a storm event occurs players are told to take cover in their cars and available shelter. If the storm event is severe we will close.

L. Please tell us how you intend to meet the landscaping requirements from the development standards and regulations found in Section 4-16.

- Our team will have to evaluated the regulation and discuss each section.
- A meeting between the county and Kiowa Creek Airsoft will need to be place to discuss their regulations as 90% of them do not pertain to our kind of business and we will be looking for exceptions

M. Will the operation be seen from any public right-of-way? How do you intend to screen the use?

• The operation can be seen from Old Victory Rd. Tree cover and netting screens the course from view. It is roughly ¼ mile off Old Victory Road





N. Provide more information about the safety and mitigation measures. Could the paintballs leave the site and impact any public right-of-way or neighboring property?

• The boundary of the course is >200 ft away from Old Victory Rd. Visibly marked. All participants must stay within the area. Where the boundary is set, paintball markers are out of range. As for Neighboring property paintball would leave back into the Mitchell Land trust

- O. What would the possible impacts to neighboring property owners and how would you mitigate concerns? What are the noise impacts? Are lights planning to be installed? You should state the hours of operation would be from sunrise till 10pm.
 - Kiowa has been operating for over 3 years at its current location. Current neighbor has had no concerns or complaints about noise. We will keep in further contact with the neighbor. All other surrounding land is owned by the Mitchell Family trust.
 - As for hours of Operation and lighting, we currently operate in the daylight hours 9am-5pm. Lighting is available around the office and storage areas for employees that arrive early morning and or stay late at night for clean up.
- P. How far do the paintballs travel? What measures will you take to ensure paintball won't leave the property? What direction will shooting take place in relation to the property boundaries?
 - Depending on the paintball marker, the average range is about 80-100 ft
 - The boundaries of the course are a minimum of 200 ft away from Old Victory Rd and neighboring properties to ensure paintballs don't travel onto Old Victory Rd and adjacent properties.
 - Shooting usually takes place going north to South shooting away from the property boundaries, towards the center of the course. If games get to close to the boundaries we end the game.
- Q. You stated everyone must wear safety gear. Do they bring their own gear? Are you planning on renting gear and or selling paintball? If so, how would this be organized and where would it take place?
 - Players are required to bring their own face/eye protection.
 - If they don't have the required safety gear they can purchase or rent it at the office/shop when they register for the day.
 - Players are required to use our paintballs for safety. This is purchased at the Office/Shop.
 - Players are permitted to use their own bbs as long as they are inspected by the game staff to be safe and biodegradable.
 - Players can buy and rent gear from the office/shop where the players register. There are two windows for two ques. One for entry/rentals the other is for gear/ammo purchases.
- R. Would you ever plan and special events for the paintball facility? If so, what kind of event would you anticipate and how many attendees? You Need to provide enough parking and be able to for a large amount of people is necessary.
 - Special events range from themed games (western, superheroes, zombies etc.) to nonstop games (games without timed breaks, players take breaks when they feel necessary.)
 - Special events usually have around 100-200 attendees with a 250 cap.
 - Parking has not been an issue, so far, for these special events.

S. Are you planning any type of special signage to advertise your business? If so, please describe what that would consist of.

• We have a sign on Old Victory Rd at the access point that has our name "Kiowa Creek Airsoft and Paintball". It will also have local groups and sponsors we support advertised on it.



T. You state you would be using theatrical props for the course. What would those consist of? And how you they look? Where are they stored? Provide picture or diagrams.

- These props are mostly old/foreign military surplus containers.
- The containers are made of wood, hard green plastic, and metal. Ranging from military surplus ammo cans to large plastic containers.
- They are stored in a storage shed next to the office. We plan on using a conex in the future to store our props

U. You state there would be protective netting to protect cars in the parking lot. What would be this netting consist of, and how would it look? How tall would it? Is the netting specially designed for paintball applications?

- Netting would consist of standard paintball netting that is used in the industry. Bought from a paintball distributor.
- Netting will be black hoisted up and strung across planted pole along the field boundary that faces the parking/staging, and office areas.
- Netting will stretch 20 feet in height

We understand the need for water and wastewater facilities at a normal daily operation. However our particular operation and business, operates 1 day a week on average with an occasional Sunday. Total operation days annually on average, 40 days. We have been in the industry for 20 years, both as a participants and management. We have traveled to numerous establishments across the US, and about 95% of these outdoor establishments do not have running water and or wastewater facilities (bathrooms) onsite. Including our home state of Colorado and all neighboring businesses do not meet these requirements. One such business exists is in Adams County, only 2 miles from the Government and county offices in Brighton, CO. We feel that our current facility is adequate to the Paintball/Airsoft industry standards across the country. In regards to building a waste water and running water facility in the future, if the business grows to the extent that it becomes necessary to introduce a facility for these utilities we will address them at the time. At the current moment the influx of money to our business makes building these facilities impractical and out of the current budget for our business. We are expecting the growth in the next 5 years might give us the ability to install these facilities and can make plans to attempt to meet this objective.




